Arms: Parted in three; 1st, gules, three cinquefoils or;
2nd, azure, a fleur-de-lis gules; 3rd, argent, an escarbuncle proper.
Supporters: Two unicorns rampant argent.
Motto: In scientia veritas, In artes honor.
(In science truth, In arts honour.)

Historical Interpretations of the Symbolism:
Argent (silver or white): Peace and sincerity.
Or (gold): Generosity and elevation of the mind.
Gules (red): Warrior or martyr; military strength and magnanimity.
Azure (blue): Truth and loyalty.
Proper: Natural colors.
Cinquefoils: Hope and joy.
Fleur-de-lis: Purity; light; floral badge of France
Escarbuncle: Supremacy; brilliant gem.
Unicorns: Extreme courage; virtue and strength.
